Purpose of the Planning Commission

The functions of the Planning Commission are set forth in Section 65101 of the California Government Code, and by Ordinance No. 96-269 as attached.

The Planning Commission is comprised of five (5) members meeting the first and third Wednesday of each month at 1:15 p.m. in Hofert Hall.

Application Process

Any citizen interested in serving on the Planning Commission is invited to complete an application form and submit it to the City Clerk's Department. All applications are then forwarded to members of the City Council, and all members of the Council will interview each of the applicants.

Qualifications

To serve on the Planning Commission, an appointee must be a resident of Big Bear Lake and a registered voter.

How Appointments Are Made

Once the interviews are conducted, the City Council will select the applicant and a formal appointment will be made at the next regular City Council meeting.

Oath of Office

Upon appointment to the Planning Commission, the appointee will be sworn into office at the next regular Planning Commission meeting administered by the City Clerk and/or his appointee.

Conflict of Interest

All members of the Planning Commission should avoid the appearance of bias in pending City matters at all times. Government Code Section 1090 provides that “members of the Legislature, state, county, district, judicial district, and city officers or employees, which includes City advisory board members, shall not be financially interested in any contract made by them in their official capacity, or by any body or board of which they are members. Nor shall state, county, district, judicial district, and city officers or employees be purchasers at any sale or vendors at any purchase made by them in their official capacity.”

Members of the Planning Commission are required, pursuant to the Political Reform Act, to file Statements of Economic Interests (Form 700) upon assuming office, annually, and upon leaving office. The City Clerk’s Office will provide the necessary information to complete the filing obligation.

Compensation

The Planning Commission shall receive the sum of Four hundred dollars per month (\$400.00) for their participation in regular, adjourned or special meetings of the Commission, set by Resolution No. 2005-13.
